MISD CCMR Data Platforms

MISD uses various data tools and platforms (SIS- Skyward, TEAL, Excel, Google Sheets, Edugence, On Data Suite, etc.) to ensure that all students get their CCMR credit before they graduate.

The Assessment & Accountability team pulls data from multiple sources monthly to determine student's CCMR progress.


The Assessment & Accountability team matches the data from multiple sources to Skyward enrollment data to determine CCMR credit for each student and shares Excel student listings with the campuses for review and verification.

Campuses review the student listings and notifies AA of any discrepancies. Campuses share score reports for new students with AA for supplemental ODS upload.




